The therapist also encouraged this young lady to remain open-minded, and expand her services to include case management. The services of the case manager were critical to ending the growing isolation the client was experiencing and the restoration of a healthy identity and self-confidence.

She will begin college in the fall with an academic scholarship and the knowledge that she possesses what it takes to continue down her path of success.





## Clients By Age





The cost for hospitalization at a state supported facility, is \$632.00 per day. The average length of stay is 12 days. The cost of community based services averages \$125 per day. By diverting 177 individuals from hospitalization, TGC saved tax payers approximately \$1,076,000.



In 2013, The Guidance Center identified and provided services for 29 homeless individuals with serious mental illness through our Program for Assistance in Transition from Homelessness grant.
